 - detained under Part 11 or section 46, 47, 48 or 136 of the Mental Health Act 1983, Parts 5, 6 and 7 or sections 136 or 297 of the Mental Health (Care and Treatment) (Scotland) Act 2003 or sections 52D or 52M of the Criminal Procedure (Scotland) Act 1995;
 - detained under paragraph 2 of Schedule 3 to the immigration Act 1971 (deportation);
 - imprisoned, detained or in custody under the Army Act 1955, the Air Force Act 1955, or the Naval Discipline Act 1957 (subject to certain conditions).
3. The above paragraph does not apply to any person detained only under section 407 of the Criminal Procedure (Scotland) Act 1975.
4. Failure to complete and return this form could lead to the award of a Council Tax Exemption or Discount being delayed or cancelled.
